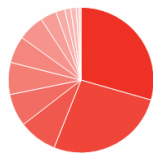

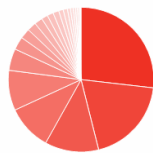
TARGET FUND ASSET ALLOCATION

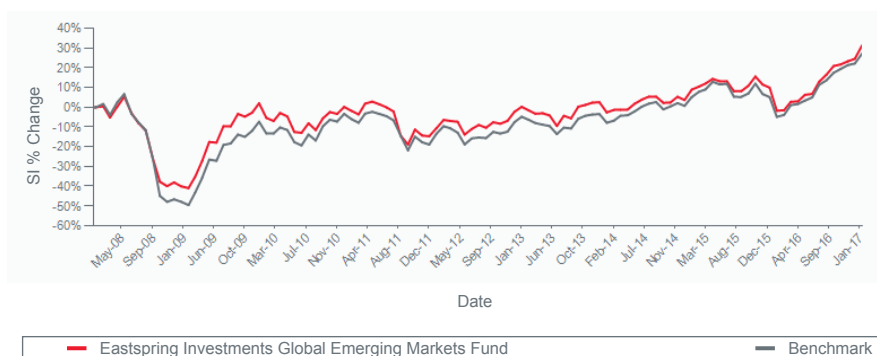

It uses investors-centred criteria to deliver a simple, clear description of a fund's success in meeting certain goals, such as preserving capital or building wealth through consistent strong returns.

Lipper Leader ratings are derived from highly sophisticated formulas that analyse funds against clearly defined criteria. Each fund is ranked against its peers based on the metric used (such as Total Return or Expense), and then the top 20% of funds in that ranking receive the Lipper Leader designation. Lipper Leaders measures are not predictive of future performance, but they do provide context and perspective for making knowledgeable fund investment decisions.

FUND MANAGER'S COMMENTARY

The fund outperformed the benchmark with country allocation and to a greater extent, stock selection supporting gains. From a country perspective, the overweight to Brazil was the largest contributor. Being underweight to Indonesia, Mexico and South Africa also added value. By contrast, the overweight to Russia detracted. At a stock level, selection in Korea generated the majority of excess returns. Our overweights to NCsoft and SK Hynix added the most to relative returns. SK Hynix rallied on strong fourth quarter earnings results that exceeded consensus forecasts. Semiconductor prices increased amid higher demand for DRAM in the mobile and computer segments. Meanwhile, video game producer NCsoft rose amid increasing recognition of the company's mobile strategy. Stock selection in India, overweight Maruti Suzuki, and China, overweight Alibaba Group, also worked well. Conversely, stock selection in Brazil detracted, notably the overweights to BRF and CCR.

Based on the Fund's portfolio returns as at 30 December 2016, the Volatility Factor (VF) for this Fund is 10.9 and is classified as "Very High" (Source: Lipper). "Very High" generally includes funds with VF that are higher than 10.605. The VF means that there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six (6) months. The VF for the Fund may be higher or lower than the VC, depending on the market conditions. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
