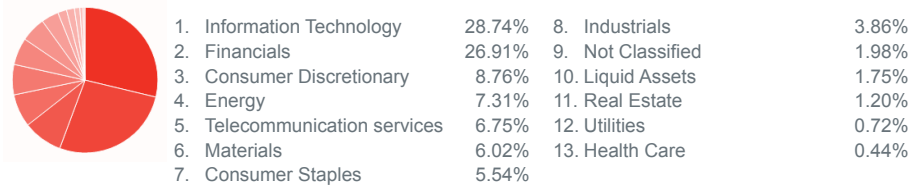

FUND OBJECTIVE

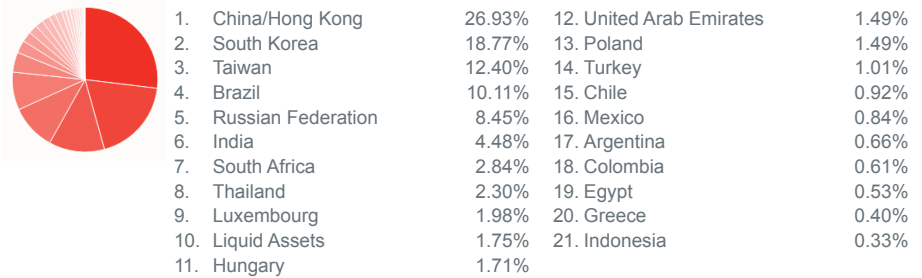

* as percentage of NAV.

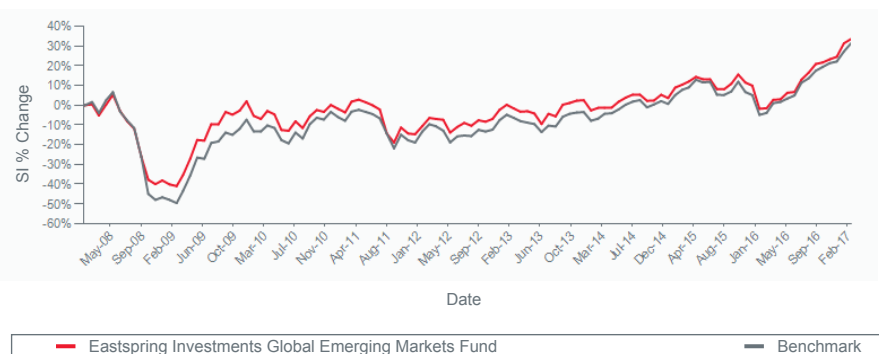

It uses investors-centred criteria to deliver a simple, clear description of a fund's success in meeting certain goals, such as preserving capital or building wealth through consistent strong returns.

Lipper Leader ratings are derived from highly sophisticated formulas that analyse funds against clearly defined criteria. Each fund is ranked against its peers based on the metric used (such as Total Return or Expense), and then the top 20% of funds in that ranking receive the Lipper Leader designation. Lipper Leaders measures are not predictive of future performance, but they do provide context and perspective for making knowledgeable fund investment decisions.

FUND MANAGER'S COMMENTARY

The fund underperformed the benchmark with country and stock selection both detracting. From a country perspective, the overweight to Russia was the key headwind. The underweight to India and overweight to Hungary also detracted slightly. At a stock level, selection in China was negative. This included the overweight telecoms company China Mobile. The defensive, low duration stock lost value against a backdrop of rising yields and positive market performance. A zero-weight to Netease also proved unhelpful as the stock rallied on expectations for growth in the online gaming sector. In India, the overweight to Tata Motors was the largest headwind. The stock declined as fourth quarter earnings results fell more than expected, negatively impacted by higher than forecast hedging losses following sterling depreciation in the face of United Kingdom exit from the European Union ("Brexit"). By contrast, stock selection in Russia was positive, in particular an off-benchmark holding in internet company Mail.Ru Group. The company posted strong earnings results and increased its guidance for 2017, sending the stock higher.

Based on the Fund's portfolio returns as at 31 January 2017, the Volatility Factor (VF) for this Fund is 10.8 and is classified as "Very High" (Source: Lipper). "Very High" generally includes funds with VF that are higher than 10.605. The VF means that there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six (6) months. The VF for the Fund may be higher or lower than the VC, depending on the market conditions. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
