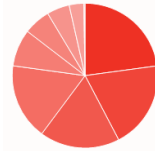

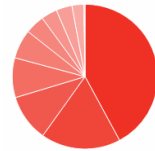
TARGET FUND ASSET ALLOCATION

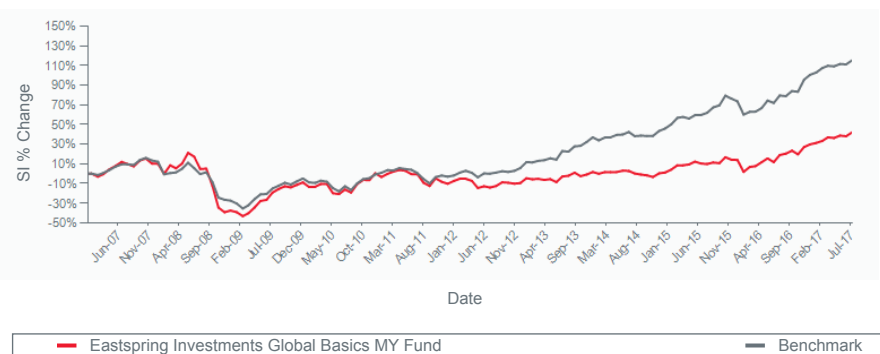

FUND MANAGER'S COMMENTARY

Global stockmarkets were generally firmer in July – particularly emerging markets. However, currency movements had a noticeable impact on returns. For example, returns for investors in the euro-share class were adversely affected by the weakness of currencies versus the euro. Over the month, the fund outperformed its composite index.

Basic materials stocks were in favour during the month and holdings in Hochschild Mining and BHP Billiton added value. Silver miner Hochschild re-affirmed guidance for 2017 production of the precious metal at 37 million ounces.

Based on the Fund's portfolio returns as at 30 June 2017, the Volatility Factor (VF) for this Fund is 11.2 and is classified as "Very High" (Source: Lipper). "Very High" generally includes funds with VF that are higher than 10.735. The VF means that there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six (6) months. The VF for the Fund may be higher or lower than the VC, depending on the market conditions. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
