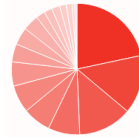

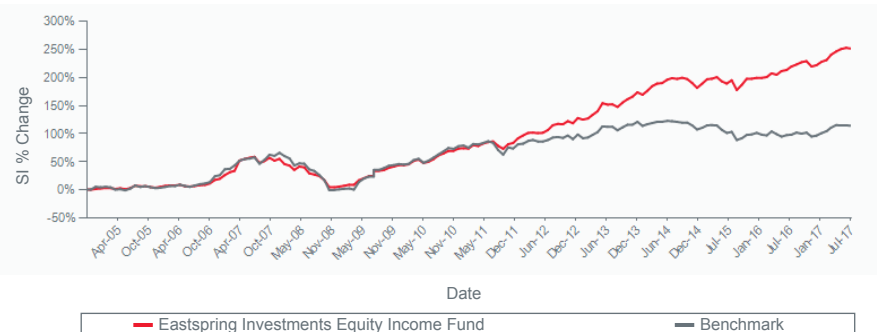

FUND MANAGER'S COMMENTARY

The Malaysian equity market had a volatile month, sparked by the lack luster response for the biggest initial public offering ("IPO") deal in Malaysia since 2012, confidence in the IPO waned culminated by the disastrous results reported on the last day of the month. The annual Invest Malaysia conference did not provide much catalyst for the market, although the Prime Minister's positive message on the state of economy and outlook provided investors with comfort. This was further supported by the International Monetary Fund's upgrade of Malaysia's Gross Domestic Production ("GDP") growth forecast for 2017 from 4.5% to 4.8%. The Kuala Lumpur Composite Index ("KLCI") ended the month slightly lower at -0.21% mom to close at 1,760.03 points. The broader market declined by 0.37%, underperforming the KLCI. The best performing sectors were Technology (+7.93%) and Industrial Production (+0.24%), whilst the worst performing sectors were Property (-3.23%) and Construction (-1.14%). The FTSE Bursa Malaysia ("FBM") Small Cap Index declined 0.97%. Average value traded on Bursa in July was RM2,156m down 15% from June's RM2,548m.

Based on the Fund's portfolio returns as at 30 June 2017, the Volatility Factor (VF) for this Fund is 6.9 and is classified as "Moderate" (Source: Lipper). "Moderate" generally includes funds with VF that are higher than 6.225 but not more than 8.225. The VF means that there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six (6) months. The VF for the Fund may be higher or lower than the VC, depending on the market conditions. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
