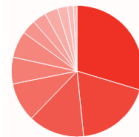

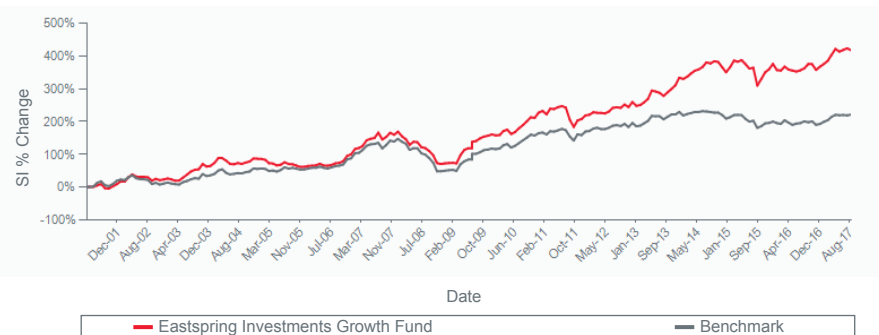

FUND MANAGER'S COMMENTARY

The Malaysian equity market was relatively flattish for the month (if not for the spike on the last day of the month), dragged by lackluster corporate earnings reported for the 2Q2017, and uncertainty regarding geopolitical tensions concerning North Korea, and the impact from US Hurricane Harvey which was the first major hurricane to make landfall in the United States since 2005. Malaysia's Gross Domestic Product ("GDP") growth for 2Q of 5.8% yoy surprising on the upside was not enough of a catalyst to drive investor interest. August saw net foreign outflows of RM0.24bn, compared to RM0.42bn of net inflows in July. The Kuala Lumpur Composite Index ("KLCI") ended the month slightly higher at +0.75% mom to close at 1,773.16 points. The broader market rose by 0.46%, underperforming the KLCI. The best performing sectors were Industrial Production (+0.84%) and Finance (+0.65%), whilst the worst performing sectors were Construction (-1.64%) and Property (-1.3%). The FTSE Bursa Malaysia ("FBM") Small Cap Index declined 3.05%. Average value traded on Bursa in August was RM2148m flat from July of RM2156m.
