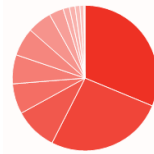

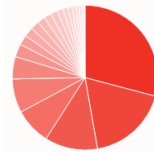
### TARGET FUND ASSET ALLOCATION

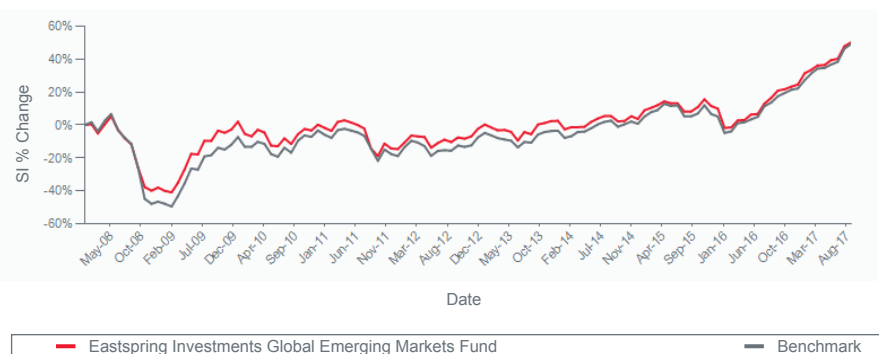

Lipper Leader ratings are derived from highly sophisticated formulas that analyse funds against clearly defined criteria. Each fund is ranked against its peers based on the metric used (such as Total Return or Expense), and then the top 20% of funds in that ranking receive the Lipper Leader designation. Lipper Leaders measures are not predictive of future performance, but they do provide context and perspective for making knowledgeable fund investment decisions.

### FUND MANAGER'S COMMENTARY

The fund outperformed the benchmark, with country allocation and stock selection contributing positively.

On a country basis, the overweight to Russia and underweight to India added the most to relative returns. Holding Hungary overweight was also beneficial. In contrast, the overweight to Korea detracted.

At a stock level, selection in China was the key contributor. This included the overweight to China Mengniu Dairy which gained as first quarter results showed improving profitability. The overweights to internet stock Alibaba Group and clothing manufacturer Shenzhou International also worked well. Alibaba raised its earnings guidance for this year while the stock gained as details of new revenue streams were released. Shenzhou announced strong second quarter results and paid an interim dividend. Stock selection in Russia was also positive, in particular the overweight to Sberbank. The stock rallied sharply, recovering from poor performance earlier this year. The valuation is attractive and fundamentals remain solid.

Based on the Fund's portfolio returns as at 31 July 2017, the Volatility Factor (VF) for this Fund is 11.0 and is classified as "High" (Source: Lipper). "High" generally includes funds with VF that are higher than 8.225 but not more than 10.735. The VF means that there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six (6) months. The VF for the Fund may be higher or lower than the VC, depending on the market conditions. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
