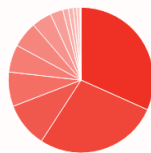

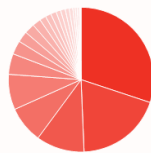
### TARGET FUND ASSET ALLOCATION

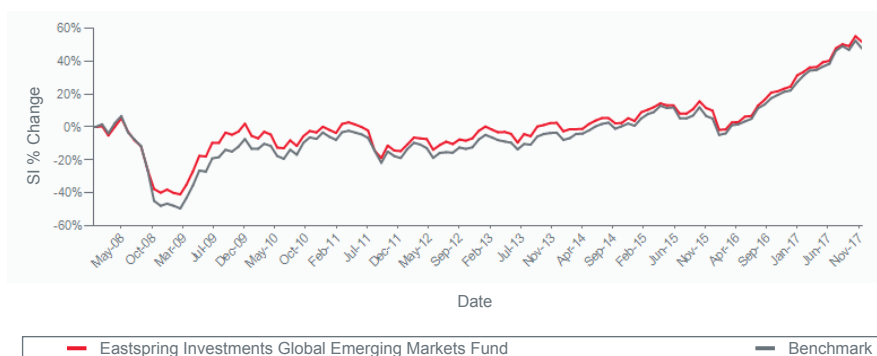

Lipper Leader ratings are derived from highly sophisticated formulas that analyse funds against clearly defined criteria. Each fund is ranked against its peers based on the metric used (such as Total Return or Expense), and then the top 20% of funds in that ranking receive the Lipper Leader designation. Lipper Leaders measures are not predictive of future performance, but they do provide context and perspective for making knowledgeable fund investment decisions.

### FUND MANAGER'S COMMENTARY

The fund returned 0.6% (A Acc Share class), outperforming the Morgan Stanley Capital International ("MSCI") Emerging Markets Index (+0.2%), with stock selection supporting excess returns.

On a country basis, the underweight to South Africa was the key headwind. In contrast, the overweight to Russia was positive.

At a stock level, selection in Russia, India and Poland added the most to relative returns. In Russia, the overweight to Sberbank was the key contributor. Q3 earnings results were stronger and supported expectations for higher dividends. In India, the off-benchmark holding in HDFC Bank worked well. The stock rallied on an improved growth outlook for the Indian economy, and as the bank continued to gain share. In Poland, the overweight to Bank Pekao added value as the stock rebounded from recent weakness. Conversely, stock selection in Korea detracted, notably the overweight to Samsung Electronics which fell on concerns that the memory (DRAM) cycle was peaking.

Based on the Fund's portfolio returns as at 31 October 2017, the Volatility Factor (VF) for this Fund is 10.9 and is classified as "High" (Source: Lipper). "High" generally includes funds with VF that are higher than 8.225 but not more than 10.735. The VF means that there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six (6) months. The VF for the Fund may be higher or lower than the VC, depending on the market conditions. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
