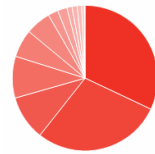

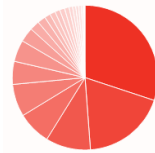
TARGET FUND ASSET ALLOCATION

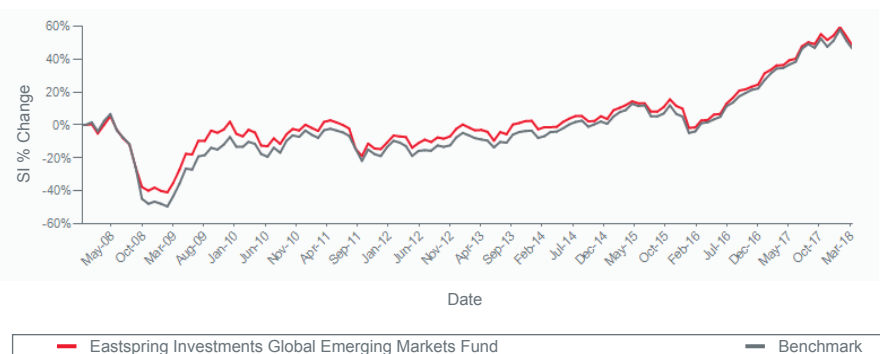

The Lipper Leaders Ratings System is a set of tools that guide investors and their advisors to select funds that suit individual investment styles and goals. It uses investor-centred criteria to deliver a simple, clear description of a fund's success in meeting certain goals, such as preserving capital or building wealth through consistent strong returns.

Lipper Leader ratings are derived from highly sophisticated formulas that analyse funds against clearly defined criteria. Each fund is ranked against its peers based on the metric used (such as Total Return or Expense), and then the top 20% of funds in that ranking receive the Lipper Leader designation. Lipper Leaders measures are not predictive of future performance, but they do provide context and perspective for making knowledgeable fund investment decisions.

FUND MANAGER'S COMMENTARY

The fund recorded a negative return of -2.4% (A Acc Share class), underperforming the Morgan Stanley Capital International ("MSCI") Emerging Markets Index (-2.0%). However, on a gross underlying basis, the fund outperformed.

Country allocation had a small positive impact on relative performance. The overweight to Korea, a zero-weight to Indonesia and the underweight to South Africa were the key contributors. By contrast, the zero-weight to Malaysia and the underweight to Poland were negative.

Stock selection was positive, notably in China. The overweight to state-controlled oil company Sinopec was the largest contributor as the stock rallied on strong earnings results and a higher than expected dividend announcement. The zero-weight to Baidu also worked well; the stock declining on relatively muted earnings results. Being overweight to China Resources Beer also added value as the stock gained on reports that the company is in talks to acquire Heineken's China business. In Brazil, the off-benchmark holding in electronic payments business Pagseguro Digital performed strongly as Q4 earnings results reflected continued solid growth. Regulatory measures announced by the central bank were also perceived as positive for the company. In India, the off-benchmark holding in HDFC Bank worked well as the stock held up better than the wider market.

Based on the Fund's portfolio returns as at 28 February 2018, the Volatility Factor (VF) for this Fund is 11.1 and is classified as "Very High" (Source: Lipper). "Very High" generally includes funds with VF that are higher than 10.615. The VF means that there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six (6) months. The VF for the Fund may be higher or lower than the VC, depending on the market conditions. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
