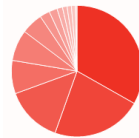

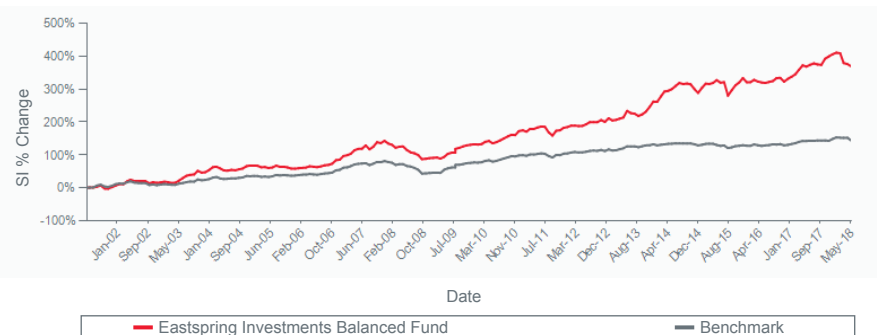

FUND MANAGER'S COMMENTARY

Equity:
May was a tumultuous month for Malaysia, starting with the 14th General Elections on the 9th May 2018, and the unexpected elections outcome. After 61 years of Barisan Nasional rule, Malaysia voted in a new government under the coalition of Pakatan Harapan (PH). The first two weeks post GE14 saw the swearing in of the new Prime Minister, Tun Mahathir, and then the subsequent swearing in of 12 cabinet ministers. May was a month of change for Malaysia, as the new government worked quickly to meet expectations as proposed in their 100-Day manifesto, starting with the announcement to set GST at 0% effective 1 June 2018 from the current 6%, and to prepare to roll out Sales and Services Tax by 1 September 2018. Malaysia's ringgit held up relatively well post GE 14, supported by the firmer crude oil prices that stayed strong as US continued their rhetoric about imposing sanctions on Iran. The KLCI closed the month at 1740.62, down 6.94% mom. The worst performing sectors were Construction (-31.34%) and Property (-6.26%). The best performing sectors were Consumer (+6.28%) and Technology (+16.29%). Average value traded on Bursa in May was RM3,350m, an increase of 35% compared to April.

Fixed Income:
In the May meeting, the US Federal Reserve ("Fed") held rates unchanged at 1.50%-1.75% after it raised its interest rates by 25bps in March. The Fed expects that economic conditions to evolve in a manner that will warrant further gradual increases in the federal funds rate. As such, the Fed is expected to follow through its hike rate path with at least another two rate hikes this year.
On the domestic front, the Malaysian bond market has been volatile since the recent general elections ("GE14") as the new government has unveiled the country's "real" fiscal position coupled with new economic policies such as the abolishment of Government Service Tax ("GST") and the continuity of fuel subsidies. Nevertheless, the Government has reiterated it will continue its effort to reduce debt while controlling spending.
There will be two government bond auctions in June, a new 20-year MGS benchmark security and a re-opening of 15-year MGII, and there is no MGS/GII maturity during the month. Malaysia's sovereign bond market is expected to be volatile as foreign investors continue to remain cautious on Malaysia. Separately, MYR corporate bond market is expected to see continuous decent supply in the pipeline in the coming month as issuers are eager to tap the market after being sidelined in May due to elections.

Based on the Fund's portfolio returns as at 30 April 2018, the Volatility Factor (VF) for this Fund is 9.4 and is classified as "High" (Source: Lipper). "High" generally includes funds with VF that are higher than 7.975 but not more than 10.615. The VF means that there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six (6) months. The VF for the Fund may be higher or lower than the VC, depending on the market conditions. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
