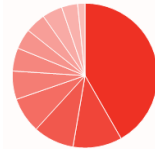

The Fund aims to provide investors with long-term capital appreciation by investing in Shariah-compliant investments with exposure to the Greater China region.

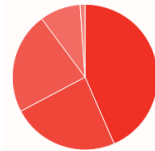

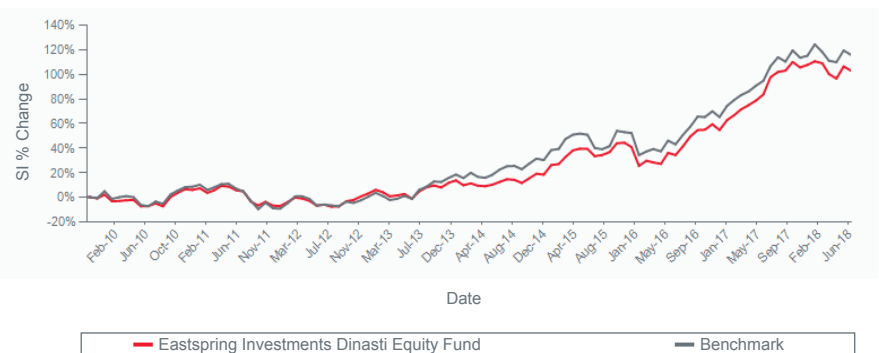

The Lipper Leaders Ratings System is a set of tools that guide investors and their advisors to select funds that suit individual investment styles and goals. It uses investors-centred criteria to deliver a simple, clear description of a fund's success in meeting certain goals, such as preserving capital or building wealth through consistent strong returns.

Lipper Leader ratings are derived from highly sophisticated formulas that analyse funds against clearly defined criteria. Each fund is ranked against its peers based on the metric used (such as Total Return or Expense), and then the top 20% of funds in that ranking receive the Lipper Leader designation. Lipper Leaders measures are not predictive of future performance, but they do provide context and perspective for making knowledgeable fund investment decisions.

FUND MANAGER'S COMMENTARY

During the month, risk appetite soured on the back of escalating fears of a trade war between the United States (US) and China. US President Trump announced that the first batch of tariffs based on the commerce department's section 301 report would be effective July 6. The list of tariffs would cover USD 34 billion of Chinese imports, targeting products related to the "Made in China 2025" program. Another list totaling USD 16 billion is currently under review. China's government also retaliated, slapping a similar 25% tariff on US imports, covering mostly agricultural products such as soybeans, corn, wheat, cotton, rice, beef, pork, poultry, as well as vehicles and aquatic products.

Against this backdrop, coupled with rising US interest rates, the Chinese Yuan (CNY) depreciated 3.28% during the month. All of the factors above led to stock markets having an abysmal month, with MSCI China Index falling 5.63%, Hang Seng Index falling 4.97% and the Hang Seng China Enterprises Index falling 7.56%. Mainland China indices were not spared either, with the Shanghai Composite declining 8.01% and Shenzhen 300 Index declining 7.66%. Major events include the People's Bank of China announcing a reserve requirement cut of 50 basis points and the US Federal Reserve hiking interest rates by 25 basis points.

In Taiwan, the Taiwan TAIEX index was more insulated, only declining by 0.35% as the strength of the US Dollar actually boosted earnings of the export centric corporate sector in Taiwan. Major news in Taiwan was the short supply of passive components which saw related suppliers' share price rally to hit new highs.

For the month under review, the fund returned -1.69%, slightly behind the benchmark's return of -1.65%.

Based on the Fund's portfolio returns as at 31 May 2018, the Volatility Factor (VF) for this Fund is 12.6 and is classified as "Very High" (Source: Lipper). "Very High" generally includes funds with VF that are higher than 10.615. The VF means that there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six (6) months. The VF for the Fund may be higher or lower than the VC, depending on the market conditions. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
