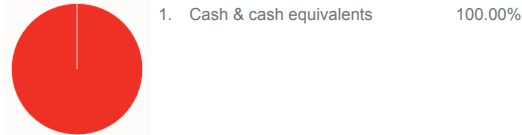

ASSET ALLOCATION



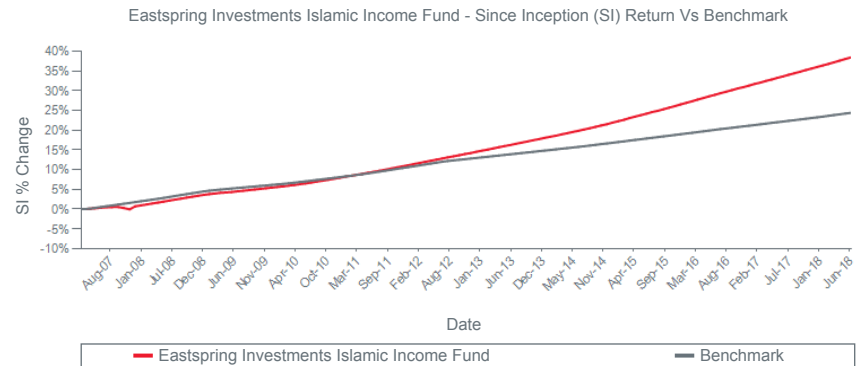

FUND MANAGER'S COMMENTARY

Interbank short term rates remained largely unchanged, with overnight and 1-week rates traded at 3.23% to 3.32%, while the 1-month rates were dealt at 3.40% to 3.41%.

Similarly, in the short-term Bills market, yields across all tenures remained relatively stable. The 1-month yields shed marginally by 1bp to 3.25%, while the 1-year yields rose by 2bps to close the month at 3.38%.

IMPORTANT INFORMATION

Based on the Fund's portfolio returns as at 31 May 2018, the Volatility Factor (VF) for this Fund is 0.1 and is classified as "Very Low" (Source: Lipper). "Very Low" generally includes funds with VF that are higher than 0.000 but not more than 1.785. The VF means that there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six (6) months. The VF for the Fund may be higher or lower than the VC, depending on the market conditions. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
