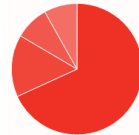

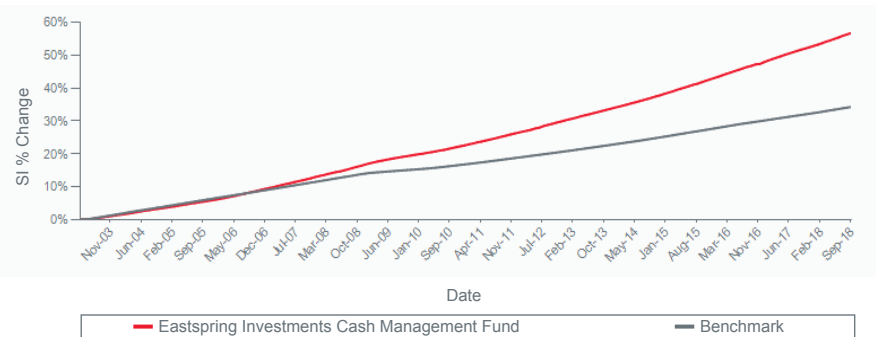

### FUND MANAGER'S COMMENTARY

BNM left the OPR unchanged at 3.25% in its MPC meeting in Sept 18. Short term interbank rates were capped within a tight range with overnight and 1-week rates traded at 3.20% to 3.32%, while the 1-month rates were relatively stable at 3.40% to 3.41%.

In the short-term Bills market, the short-term Bills were well supported and remained largely unchanged across all tenures during the month. The 1-month bill traded close to OPR level at 3.25% while the 1-year yields ended the month at 3.33%.

Based on the Fund's portfolio returns as at 31 August 2018, the Volatility Factor (VF) for this Fund is 0.2 and is classified as "Very Low" (Source: Lipper). "Very Low" generally includes funds with VF that are higher than 0.000 but not more than 1.885. The VF means that there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six (6) months. The VF for the Fund may be higher or lower than the VC, depending on the market conditions. The Fund's portfolio may have changed since this date and there is no guarantee that the Fund will continue to have the same VF or VC in the future. Presently, only funds launched in the market for at least 36 months will display the VF and its VC.
